Terms and Conditions

Note: Your event is only guaranteed once we have received both the completed booking confirmation and deposit

- 1. Deposit:** A non-refundable deposit of \$1,000 is required to confirm a tournament date at Niakwa Country Club
- 2. Payment Schedule:** Balance is due Net 15 days. Business cheques should be made out to Niakwa Country Club. No personal cheques will be accepted.
- 3. Food & Beverage:** All tournaments held at Niakwa Country Club must reach a minimum Food and Beverage spend of \$55 per golfer (before gratuity & tax). Menu selection must be submitted at least 3 weeks prior to event and final attendance numbers dinner must be confirmed 7 days prior to the event. Please refer to the Tournament Planner for all other Food & beverage options, details, policies, and requirements.
- 4. Attendance Guarantee:** A guaranteed number of participants must be confirmed 10 days in advance. Failure to comply or meet minimums will result in forfeiture of deposit.
- 5. Tournament Detail Sheet:** The event tournament detail sheet and a players list must be returned to Outside Events manager 7 days prior to the event.

Inspection: Niakwa reserves the right to inspect and control all functions held on the premises. All laws governing the sale, purchase, distribution and consumption of Alcoholic beverages will be strictly enforced.

The tournament sponsor accepts responsibility for all damages caused by the sponsor, its guests, event participants, agents or employees to the club's facilities named Niakwa Country Club.
